## ※ Special Notice for Enrolled students who exceed the minimum term of study

### ① What is the meaning?

– It is stipulated that students who did not complete the academic program with exceeding the fixed minimum term of study should pay the tuition fee in accordance with UST provision (Minimum term of study for Master's and Doctoral Program : 4 semesters / Integrative Program : 8 semesters)

### ② Note

– The amount of tuition fee depends on the credits made in this semester

Applied credits	Charged proportion
1~5	40% of total amount of tuition fee (KRW 1,000,000)
6~10	70% of total amount of tuition fee (KRW 1,750,000)
11 and over	100% of total amount of tuition fee (KRW 2,500,000)

##### 1. Check the Tuition fee invoice

###### · Where?

– UST System(<http://edu.ust.ac.kr>) → Management of Registration status → Student Tuition inquiry → Click the button of “Print out”(on the above right side)



##### 2. Pay the tuition fee to the provided Individual account number on Tuition invoice

###### · Tuition Amount

– General Student : 2,500,000 KRW / Person

###### · Periods

– General Students : Aug 16(Tue.) ~ Sep 5(Mon.)

– Enrolled students who exceed the minimum term of study : Oct 3(Mon.) ~ Oct 7(Fri.)

## ② Installment Payment

(Only for applicants for the installment payments)

### 1. Check the Tuition fee invoice

#### · Where?

– UST System(<http://edu.ust.ac.kr>) → Management of Registration status → Student Tuition inquiry → Click the button of “Print out”(on the above right side)



### 2. Pay the Tuition fee to the provided Virtual Account Number (1st installment)

#### · Tuition Amount

– General Student : 625,000 KRW / Person (25% of Total Tuition amount)

#### · Periods

– General Students : Aug 16(Tue.) ~ Sep 5(Mon.)

– Enrolled students who exceed the minimum term of study : Oct 3(Mon.) ~ Oct 7(Fri.)



### 3. Pay the tuition fee to the provided account number (2nd ~ 4th payment)

#### · Tuition Amount

– 625,000 KRW / Person (25% of Total Tuition amount)

#### · Periods

## Important Remarks

- ☐ One who has not completed payment of tuition fee for each semester during the given period without a good reason would be **expelled**.  
(Refer to Article 28 at Academic Regulations, Article 8 at Tuition Regulations)
- ☐ Only when the students who have applied for installments pay the 1st installment within the period, the entire installment payment plan will be valid.

- ※ As well as the application, confirmation from your advisor and campus representative professor must be done during the application period.
- ※ When application through the UST Integrative system fails, you can fill out and submit the document of Attachment 2., with full confirmation(signatures) of related professors. (Email of scanned file or original copy is acceptable.)

## ☐ How to Pay

- ① Full Payment on delayed date : 100% of tuition on the designated date.
- ② Installment Payment on delayed date : 25% of tuition on each designated date.

## 6 Tuition Exemption

- ☐ According to the UST Tuition Regulations, students may get tuition exemption.

**ARTICLE 4 (Tuition Fee Payment)**      ④ The university president may exempt or reduce the tuition fees for students who fall under any of the following clauses.

1. If the payment of tuition fees is difficult due to inevitable reasons, such as natural disasters, etc.
2. If deemed necessary to the promotion of learning.

- ☐ Students wishing to apply for the tuition exemption should fill out the form of attachment 1 and submit it to the Educational Affairs Division.

## 7 Tuition Refunds

### ☐ The Reason for Refund

No.	Reason
1	A student who submits the Request for Voluntary Permanent Academic Leave
2	A student who submits the Application for Leave of Absence
3	A student who submits the Application for Cancellation of Admission Registration
4	A student who has dropped out of an integrated program(But if the student cannot meet the requirement of course completion of Master's degree, It would not be refunded)
5	A student who has been expelled
6	In case a student is not able to accept the offer of admission (including readmission) due to unavoidable reasons such as his/her death or natural disaster.

### ☐ Criteria for Tuition fee Refund

Time for Filing a Claim for Refund	Refund percentage
Prior to the first 30 days from the commencement of a semester (Sep 1~Sep 30)	100% of the tuition fee
Between the first 60 days and the first 30 days from the commencement of a semester (Oct 1~Oct 30)	2/3 of the tuition fee
Between the first 90 days and the first 60 days from the commencement of a semester (Oct 31~Nov 29)	1/2 of the tuition fee
90 days and onward after the commencement of a semester (Nov 30~)	No refund

※ Amount less than KRW 1,000 shall be cut.

**NOTE****FAQ**

	Question	Answer
Payments	I've passed the minimum study duration but failed to become course completion in this semester, owing to the remaining credits. Should I pay the tuition fee?	You are typed as an enrolled student who exceeded the minimum term of study, so you are required to pay the tuition fee depending on the number of credits you will apply for.
Virtual account number	When can I pay the tuition fee to the virtual account?	Any time is possible during the given business days (but, It will be blocked for 2 mins from 23:59 for IT adjustment.)
	Can I pay the tuition fee separately to the account?	No, you can only transfer the exact amount of money to the virtual account number.
Installment Payment	I exceeded my minimum term of study, can I apply for installment payment?	Yes, you can. After your course registration is completed, your final tuition fee will be calculated and you are to pay 1/4 of that amount each time.
